Mr. Garrett inquired as to if they are opening a brewery. Mr. Eichman stated that they will not be brewing here. CB & Potts is hoping to open November 12. Mr. Garrett inquired about the bar location. Mr. Eichman stated that the bar is still upstairs. Mr. Tatro inquired into Mr. Eichman's experience. He stated that he has been a GM for CB & Potts for 4 years. He is TIPS trained, but they are requiring ServeSafe for all employees before they can start work. Mr. Montepare inquired more about CB & Potts. Mr. Eichman stated that they bought the building from Landry's and have no affiliation with them. Ram International is the parent company and they have 33 restaurants in the United States. This will be their 8th restaurant in Colorado. Chair Katz inquired about ServeSafe. Mr. Eichman stated that it is essentially the same as TIPS. The consent calendar stood as approved.

a) Public Hearing

Alpine Sports, LLC d/b/a Alpine Sports 435 N. Park Avenue Beer & Wine License

Chair Katz stated that she had a conflict of interest and asked the LLA if they believed that she had a conflict of interest. She stated that the new licensee is a client and that she has been told the executive session is also about a client of hers. The Authority agreed that she has a conflict of interest and allowed her to recuse herself for the rest of the meeting.

Mr. Thos McDonald introduced himself as one of the owners of Alpine Sports. He stated that they have a coffee shop in their store that they would like to get a beer and wine license for. They would like to extend the hours of the coffee shop past 2 PM (the time that the shop currently closes). They would like to be able to host speaker series and fund raisers for kid's sports while bringing in a little bit more business in the afternoons. Mr. Tatro inquired as to what would be on the menu. Mr. McDonald stated that it would be beer and wine only. Mr. McDonald stated that his partner used to operate the Vista Haus and has experience in the industry. He stated that the coffee shop staff would be separate from the store staff. Mr. Montepare stated that he would like to see everyone TIPS trained. Mr. Garrett stated that he would have liked to see the location prior to the hearing and asked Mr. McDonald to describe his space. Mr. McDonald stated that the coffee shop is in its own area. Mr. Garrett inquired about the patio area out front. Mr. McDonald stated that there is a patio area that is surrounding by rocks and shrubs to create separation and a buffer. Mr. Montepare stated that he is seeing this concept around where you go to a ski/bike shop and grab a beer or a cup of coffee.
