- 1) Call to Order, Roll Call Chair Katz called the regular meeting of Tuesday, January 17, 2017, to order at 9:00 am.
- 2) Approval of Minutes
  With no changes or corrections to the meeting minutes of December 20, 2016, Chair Katz
  declared they would stand as approved.
- Approval of Town of Breckenridge Liquor & Marijuana Licensing Authority Annual Report A correction was made to the LMLA annual report to update the list of members on the first page of the report to remove Dave Garrett and add Leigh Girvin. With no further corrections to be made, Ms. Girvin motioned that the Town of Breckenridge Liquor & Marijuana Licensing Authority Annual Report be approved. A roll call vote was taken and all members were in favor.

Mr. David Jaime Lang introduced himself as the owner of Muncheeze, now known as The Hangar. Mr. Lang stated that he is originally from Kentucky, moved out to Crested Butte and ended up staying in the mountains. Ms. Girvin inquired as to his previous experience with liquor licenses. Mr. Lang stated that he has no experience and that he is not TIPS trained, but is on the list to take the training. Mr. Blank inquired as to what he is going to change on the menu and business wise. Mr. Lang stated that he is going keep things mostly the same but will try to keep the ingredients local. Mr. Tatro stated that one of the things to be careful of is failure to report an incident as it is the responsibility of the licensed establishment to report any incidents that occur to the police department. Mr. Lang stated that the first thing he did was get rid of the free beer night to help to eliminate any problems from arising. With no further questions and no changes to the agenda, the Liquor Consent Calendar stood as approved.

Detective Kontak stated that the barrier seemed to work well. Ms. Girvin stated that she didn't get there early enough to sign-up for the shot ski. She went to observe and noticed that, in front of CB & Potts, the staff was hanging out in front of the shot ski and one was allowed to get onto the shot ski while in full work uniform. Ms. Girvin stated that there will always be someone who tries to sneak onto the ski, but overall it looked like

Ms. Girvin stated that they had discussed Oktoberfest at the liquor subcommittee of the Events committee. Ms. Girvin state that she had requested that the Breckenridge Tourism Office be present three months prior to Okotberfest to discuss their licensing plans. Chair Katz stated that some of the business owners stated that they are upset that the two most troublesome events are "Town sponsored."
