 Chair Katz called the regular meeting of Tuesday, June 21, 2016, to order at 9:00 am.

 Chair Katz stated that there are a few different locations that have voiced concerns
 about the safety of the horse shoe pits at Kenosha/Rita's late at night. Deputy Kontak
 stated that patrol is increasing security at night. Ms. Girvin stated that the LMLA
 would like a letter sent to the applicant stating that they have some concerns.

 - i) Blue Sage Spa, Inc. d/b/a Blue Sage Spa 224 S. Main St. Beer & Wine License

Ms. Karen Mapes, Co-Owner of Blue Sage Spa, stated that they have been toying with the idea of getting a liquor license for the past few years and as they are now offering more services they would like to be able to offer beer & wine to their clients. Mr. Tatro inquired as to what experience Ms. Mapes and her staff have with liquor. Ms. Mapes stated that she managed Pasta Jay's in the past. Mr. Tatro inquired about TIPS training and Ms. Mapes stated that she will get the staff trained. Mr. Montepare stated that his concern would be more about someone coming in who had already been drinking as opposed to them over serving. Chair Katz stated that she believes that the concern may be wedding parties, to make sure that they are all of age and to make sure that they don't get out of hand. Chair Katz closed the public hearing. Ms. Girvin moved to approve the license. 5-0 passed.

Detective Kontak stated that there have been two break-ins at Breckenridge Organic Therapy and had just completed inspections on all marijuana licensees. The write-ups will be brought to the LMLA at the next meeting. Detective Kontak stated that the break-ins were eight days apart and the individuals breaking in got away with a small amount of cash, the product in the fridge and the product in the counter. Chair Katz stated that Wellington has been very busy on Friday and Saturday and that she is

concerned as we are not even to peak tourist season. Chair Katz stated that The Brown has been busy and she believes that it is contributing to the late night traffic. Mr. Blank inquired about the allowable decibel level for outside music. Detective Kontak stated that we are on par with other towns. Ms. Girvin inquired as to if Council could review the decibel level. Mr. Tim Berry, Town Attorney, stated that the decibel level was set by state statute. Ms. Girvin stated that the music was so loud opening night at The Brown that it was uncomfortable.
