- 1) Oath of Office Swear in Timothy Faust to the Liquor & Marijuana Licensing Authority
- 2) Call to Order, Roll Call Chair Katz called the regular meeting of Tuesday, March 21, 2017, to order at 9:00 am.
- 3) Approval of Minutes
 With no changes or corrections to the meeting minutes of February 21, 2017 Chair Katz
 declared they would stand as approved.
- Approval of AgendaMs. Power, Deputy Town Clerk, stated that there were no changes to the agenda.
- 5) Consent Calendar

Mr. Jacob Lewitt, General Manager of Dancing Pines Distillery, stated that they are based in Berthoud and have a tasting room in Estes Park. The distillery produces whiskey, gin, rum, liquor and a lot of other products. Ms. Girvin inquired if they have been at Still on the Hill. Mr. Lewitt stated that they have. Ms. Girvin inquired to the location of the tasting room. Mr. Lewitt stated that they are moving into Petal & Bean. Ms. Girvin inquired about TIPS training. Mr. Lewitt stated that he is certified as a trainer and they do their training in house.

b) Marijuana Consent Calendar

Mr. Frank Quattrone, owner of Organix, stated that he operates several cannabis operations in Denver under Pure Marijuana Dispensary. Mr. Quattrone stated that cannabis is a large industry in Israel and his partner is currently there at a conference. Mr. Blank inquired as to where the cultivations are. Mr. Quattrone stated that they have one cultivation license in Breckenridge and one in Denver, but that most of the cultivation takes place in Denver.

The following is an abbreviated summary of what transpired at the hearing. A verbatim tape recording was made of the entire hearing as required by Rule 26.12 of the Rules of Procedure of the LMLA.

Mr. Tim Berry, Town Attorney, stated that this renewal application was removed from the last LMLA agenda to set a renewal hearing for conduct of establishment. A notice was sent to the licensee of the hearing. Following the notice, staff was made aware of sale to a minor that the LMLA needs to be made aware of. Mr. Berry stated that the licensee had not yet been noticed for this. Mr. Bob Gregory, Town of Breckenridge Prosecuting Attorney, stated that since this hearing was noticed there has been a new allegation and summons issued to Terry Barbu, owner of Blue Stag Saloon. Mr. Gregory stated that there are essentially two incidents that the LMLA should

consider on the basis of renewal. Mr. Gregory stated that there is conduct of establishment for a drug bust that happened on the premises and an incident with sale of alcohol to a minor. Mr. Gregory stated that Mr. Barbu was just notified of this today and is not prepared to speak to that today. Chair Katz stated that Mr. Barbu has a criminal proceeding in municipal court and that if he is going to admit to the charge today, it can be used against him in municipal court tomorrow. Chair Katz stated that Mr. Barbu has the opportunity to be represented by an attorney. Mr. Barbu stated that he knows that he has the option of the attorney. Mr. Barbu stated that he has invested \$3,000,000 into this town, that this is a business and that he is taking everything very seriously. Chair Katz stated that the hearing will be continued to May 16.

 There was no public comment.

Mr. Berry stated that there is a conflict with the hearing for HERO. The counsel for the licensee is unavailable for the hearing in May. Chair Katz stated that the HERO hearing has been continued at the request of the licensee until the June LMLA meeting.

At 10:11 am Mr. Tatro moved for the Authority go out of executive session and reconvene in the regular meeting. A roll call vote was taken. All members were in favor of the motion.
