### I) CALL TO ORDER, ROLL CALL

Mr. Holman stated the Breckenridge Ski Resort would not be present for an update.

#### IV) COMMUNICATIONS TO COUNCIL

A) CITIZEN'S COMMENT - (NON-AGENDA ITEMS ONLY: 3-MINUTE LIMIT PLEASE) Mayor Mamula opened Citizen's Comment.

Mr. Nate Thomas, a local resident, stated he wanted to clarify some misconceptions about a merger between Everist Materials and Peak Materials during the last 12 months. He stated that while the demand has outgrown the supply, and there are some growing pains, the company is doing their best to meet demands and keep prices competitive. He further stated they like to be transparent, especially when it comes to local projects. Mayor Mamula stated the concern is more about supply and Mr. Thomas stated the supply has been an issue and they will strive to improve that in the future.

Mr. Scott Prescott, a local business owner, thanked Council for the activation around the snow sculpture competition, and encouraged everyone to continue to work together for a better guest experience.

# C) BRECKENRIDGE TOURISM OFFICE UPDATE

Ms. Sandy Metzger, Events Manager for the BTO, stated the Snow Sculpture competition was a success, and they are receiving feedback on that now from local businesses. She further stated there were good media impressions (including The Travel Channel), and community support. Ms. Metzger stated that a survey conducted during the event indicated that 73% of attendees came specifically for this event. She also stated that a meeting tomorrow will look at options for the event next year. Mr. Bergeron asked about international vs. national teams, and Ms. Metzger stated the quality was high for all teams.

Ms. Lucy Kay, director of the BTO, thanked the Ski Resort for its supply of snow for the event, and also stated that the drivers who took down the sculptures did an amazing job. Ms. Kay stated the BTO is moving forward with the conversation regarding the tourism master plan and the tourism road map idea. She stated the occupancy for the rest of the year is trending up, and asked for staff to involve the BTO in wayfinding and broadband conversations in the future.
