B) BRECKENRIDGE TOURISM OFFICE UPDATE

Ms. Lucy Kay, Director of the Breckenridge Tourism Office, stated the Fourth of July parade was an hour long, a great length for a parade. Next year, they will tell the restaurants to expect the parade to end earlier, so they can be ready for crowds. Jeffrey & Elizabeth did a great job as emcees. Occupancy was around 87%. Occupancy is still slightly behind for summer, which is the same for most other mountain towns, except Glenwood Springs, Colorado Springs and Denver. They were happy with the Solstice event, which drew six attendees, including Ashton Altieri from Denver Channel 4, Jim Cantore, and a top Dallas station. They are currently working on a comprehensive master plan for responsible tourism. Some employees from Town departments assisted with interviews for their new Director.
