- 1) Call to Order, Roll Call  
Chair Katz called the regular meeting of Tuesday, February 18, 2020, to order at 9:00 am. The following members answered roll call: Ms. Power, Ms. Girvin, Mr. Faust and Chair Katz. Mr. Vatcher was absent.
- 2) Approval of Minutes  
With no changes or corrections to the meeting minutes of January 21, 2020, Chair Katz declared they would stand as approved.

Ms. Tara Olson, Deputy Clerk, stated there were no changes to the agenda.

  - a) Liquor Public Hearing for a New License Application  
*Adventure Time Escape Rooms LLC dba Mountain Time Escape Rooms  
226 S Main St, Units 4 & 5  
Beer and Wine License*  
Reba Martinez introduced herself as one of the owners of Mountain Time Escape Rooms, which she runs with her daughter. She explained that they have three locations, but this application is for the 226 South Main Street location, as they have a large, open room. They would like to hold events and shows, in conjunction with the escape room, and make it more of an “evening out”, with catered dinners, and offer beer and wine. The liquor service would be for the murder mystery type shows, not regular escape room activities.  
Mr. Faust moved to approve the liquor license for Mountain Time Escape Rooms. A roll call vote was taken and the motion passed 4-0.
- 6) Informal Discussion
  - a) Police Department Update  
Assistant Chief Gress spoke about an incident at Burke & Riley’s. A bartender was inebriated at work, received a citation, and had to be sent home. PD will do some follow-up on that, and see if that person has attended TIPS training, and make sure they do, if they have not, already.  
Assistant Chief Gress asked if they would like him to do the call spreadsheet, in Detective Johnson’s absence. There was some discussion about having too much information, and whether it is helpful for their decisions, or if it perhaps influences them in a negative way. They decided they would like to continue receiving it, if someone could provide it.
