- OUNCIL BILL NO. 10, SERIES 2020 AN ORDINANCE AMENDING CHAPTER 1 OF TITLE 9 OF THE BRECKENRIDGE TOWN CODE, KNOWN AS THE "TOWN OF BRECKENRIDGE DEVELOPMENT CODE," BY AMENDING POLICY 24 (ABSOLUTE) AND POLICY 24 (RELATIVE) CONCERNING HOUSING Mayor Mamula read the title into the minutes. Ms. Nichole Rex stated this ordinance would add an absolute policy and revise the current policy. She stated staff has made several revisions from the Work Session for second reading, including definitions, submittal requirements, removing land in lieu, changing the mitigation rate, and more, and she would also propose adding a commercial density bonus back in for second reading, with a potential cap for bigger projects. Mr. Carleton thanked staff for their work on this ordinance.
