Transfer of Ownership of a Hotel & Restaurant License from BV Projects LLC d/b/a The Lost Cajun - Breckenridge

Owner Isabelle Heraud and her bookkeeper, Chris Conway, were present on behalf of La Francaise Bistro. Ms. Heraud stated she and her husband have been in the restaurant business for 30 years, here, and in France. When they moved to the United States, they first settled in Florida and opened a restaurant there. They missed the snow and the Alps, so they moved to Breckenridge, where they have owned and operated La Francaise French Bakery for a few years. When they had the opportunity to acquire the restaurant space next door to their bakery, they jumped on it. They are excited to open their new French bistro. Ms. Power asked about their hours. Ms. Heraud said they anticipate being open 6 days a week, from 5PM – 9:30PM. They will offer some cocktails and French wine for table service – they do not intend to operate it as a "bar". Ms. Girvin asked about TIPS training. Ms. Heraud believes one of her staff already is. Ms. Power recommended they check in with the Breckenridge Police Department, to sign up for TIPS training through them, for all of their service staff.

Mr. Conway made a motion to approve the Transfer of Ownership application. A roll call vote was taken and the motion passed 5-0.
