#### I) CALL TO ORDER, ROLL CALL

With no changes or corrections to the meeting minutes of January 11, 2022 Mayor Mamula declared they would stand approved as presented.

Mr. Holman stated there were no changes to the agenda. Mayor Mamula declared the agenda approved as presented.

Mr. Dan Corwin stated he walked into town yesterday and it was dangerous. He further stated the past program left the Town responsible for evenings and mornings, with property owners responsible for clearing during the day. He stated some properties take on this responsibility, while others do not, and we want to make the sidewalks more inviting and safer.

Ms. Laurie Best stated this ordinance would annex a small piece of property that is owned by the Town as required to subdivide the McCain property. She further stated there are no changes to this ordinance from first reading.

She also stated there is a public open house around the first week of March for the Open Space Master Plan, with a final report in March and a recommendation to Council in April. She also stated there is a documentary planned about the Cucumber Gulch beavers.

Mr. Kuhn stated the BTO has their planning meeting this week, and February 1 will be Barney Ford Day, including education at Breckenridge Elementary School and a proclamation at the capitol.

### I. SOCIAL EQUITY ADVISORY COMMISSION

Ms. Gigliello added there is a local significance in that name and stated other names are being explored to honor the original intent.

Mayor Mamula stated we will need to look at water rates again soon. He also suggested the Housing Fund pay 100% of PIFs and the Water Department would retain those funds.

#### X) OTHER MATTERS

Mr. Bergeron stated the B&B and Sallie Barber trails are messy with dog poop, and perhaps there's something more that can be done to help solve that problem. Ms. Gigliello stated she will bring the issue to BOSAC.

Mayor Mamula stated he had lunch with Jody Churich from the Ski Resort, and they talked about the parking structure and the VMS sign. He stated the ski resort would like a bus lane on Airport Road, and would like to explore combining our transit systems in a cohesive way.

Mayor Mamula stated the snow on the sidewalks has been really difficult to manage, and he would like to know what Public Works needs to better deal with them. He also stated he disagrees with Mr. Corwin's comments because most employers are understaffed to shovel the sidewalks. Mr. Bergeron added it is weather and short staffing and we should see what we can do to improve them.

Mr. Bergeron asked about pedestrians crossing at the Village and Mr. Holman stated we are already short staffed for flaggers on Park Avenue by the garage so it is not a top priority. Mayor Mamula noted the crossing counts on the underpass are up as well.
