Legislative Items

- Opt-out of state FAMLI The state recently passed legislation created a Family Medical Leave Insurance plan. To fund the plan, employees and employers would pay into the fund and, in general terms, employees would be able to utilize the fund to receive pay while on FMLA. Municipalities are allowed to opt-out of the program. The Town is currently considering if we should opt-out.
