I. Required Meeting Items (7:30-7:35)

II. Public Comment (Non-Agenda Items) (7:35-7:45)

Bill Wishowski, BTO, update on Hispanic Engagement Kicking off an Beginner English Language program in partnership with CMC Enrollment is planned for January, program to start in February Start, 25 people max for each session

Program is planned to be 12 weeks long; still determining best schedule (1 - 3hr session/week, 2 – 1.5 hr. sessions/week, could be morning or afternoon Commission Feedback

- 3 hours will be difficult for people; check to see what they need, what they can participate
- Needs to be in person

CMC will run the program and hire the instructors. Likely location is CMC, but there might be a class at BGV as they will be funding the first class. The BTO is planning to fund the 2^{nd} class. Each class is \$2,500. Bill has a list of 15 organizations to reach to for fund assistance. They are planning to engage the Summit Foundation and hope to raise money from the Town. Hopefully some businesses will pay the enrollment fee, then the BTO can utilize funds to "pay it forward" for future classes. They would like to grow the fund of \$10K so the program is perpetual and CMC can plan for instructors.

Commission Feedback

- Find out where people want to meet and the best times and how long the classes should be

Marketing: Similar to how they did their initial engagement. Meet people where they are (i.e. transit center, businesses, etc.). They plan to speak about \$2K in marketing/communication. The BTO is hoping to add a Spanish section of the DMMO Download.

Enrollment does not require documentation, simple application. Scholarships will be available.

Commission Feedback

- Scholarships - suggest making people pay for some portion of the program to ensure buy in and value

Need a name for the program: Commission suggestion: "Let's Begin Together" in Spanish

Silvia will attend Bill's next planning meeting

Dana provided a general overview. Topic will be rescheduled for a future meeting.

IV. Open Space and Trails Master Plan Feedback (8:05-8:20)

Anne Lowe, Open Space & Trails Manager

Anne provided an overview of the goals and intent of the Open Space & Trails Master plan. The Commission provided the following feedback:

- Photos need to have more diverse images; need to have some brown people
- At times the plan is very broad, general and then it gets very specific; need to stay
- To ensure the plan is inclusive, keep broad and then work with members of various communities, get their feedback, and make changes
- Remove QR codes as a section, Make it communication as a whole
- Access as new neighborhoods come online
- Not "accessible trail loops", just "accessible"
- Translation At trailheads consider the use of pictures instead of languages, don't just focus on Spanish
- Engaging different cultures to participate is often not a matter of economics, but an issue of feeling included

Black History Month Banner Feedback

Compensation for Town Commissions

- The commission recommends compensation for all Council appointed commissions.
The level of compensation should be commensurate with the level of work required.
Pride Event Planning Committee Volunteers — The commissioners recommended engaging the Cultural Diversity sub-group.
