Blank asked if there is state law verses local law examples that can be discussed. An example would be our violation addressing over intoxicated employees. Sgt. Jagusch brought up the example of a "service to an intoxicated patron" ticket written to a Salt Creek bartender. The citation is still in County Court. Sgt. Jagusch stated "over service" does not have a definition. It was also asked if tickets issued to patrons for offenses occurring outside an establishment's designated premises can be associated to a certain liquor licensed premises. It was determined that the October meeting would be preferred. At that time the Authority will be getting an Oktoberfest update.

## PUBLIC HEARING - APPLICATION FOR A NEW BEER & WINE LICENSE

### PROCEDURE FOR HEARING ON APPLICATION FOR A NEW BEER & WINE LICENSE

- 1. The next order of business will be the public hearing on the application of Pete's Billiards Inc. for a new Beer & Wine License for Pete's Billiards & Arcade at 500 S. Main Street, Units 1F & G, Breckenridge, Colorado.
- 2. *Announce* The application was filed on August 10, 2009, and public hearing thereon was set for 9:00 a.m. on the 15<sup>th</sup> day of September, 2009. The neighborhood boundaries were established to be the Upper Blue River Basin, with general boundaries being Farmers Korner to the North, Hoosier Pass to the South, the Continental Divide to the East, and the top of the Ten Mile Range to the West.
- 3. **Announce** At this hearing, the Liquor Licensing Authority shall consider the evidence presented, the reasonable requirements of the neighborhood, the desires of the inhabitants for the type of license for which application has been made, and the qualifications of the applicant for the conduct of the type of business proposed.

#### 4. Ask the Town Clerk the following:

- a) Has the license application together with all supporting documents been received by you?
- b) Has the property been posted and notice of this hearing published?
- c) Have you received any communications in favor of, or in opposition to the application?
- 5. Announce The applicant may now present her evidence.
- 6. **Announce** The opponents, if any, may now present their evidence.
- 7. *Inquire* of the Liquor Licensing Authority if they have any questions.
- 8. After all Liquor Licensing Authority questions are completed, *announce* that the hearing on the application will be considered closed.
- 9. Announce I will entertain a motion as to whether or not the application should be granted.
- 10. **SAMPLE MOTION TO GRANT LICENSE:** "I move we approve the application of Pete's Billiards Inc. for a beer and wine license for the premises to be located at 500 S. Main Street, Units 1F & G, based on the applicant's showing of the reasonable requirements of the neighborhood and the desires of the citizens and subject to the applicant receiving a favorable background investigation."
