Breckenridge Liquor and Marijuana Licensing Authority Regular Meeting Tuesday, November 15, 2022

1) Call to Order, Roll Call

Chair Power called the regular meeting of Tuesday, November 15, 2022, to order at 9:00 am. The following members answered roll call: Mr. Conway, Ms. Girvin, Ms. Zimmerman, Ms. Lovely, and Chair Power.

2) Approval of Minutes

With no changes or corrections to the meeting minutes of October 18, 2022, Chair Power declared they would stand as approved.

3) Approval of Agenda

Ms. Tara Olson, Deputy Clerk, stated there was an addition to the Liquor Consent Calendar for the renewal of a Hotel & Restaurant license for DCB Café LLC d/b/a Cool River Coffee House, located at 325 S Main St.

Chair Power declared the agenda would stand approved as amended.

The Liquor Consent Calendar stood approved as amended.

5) Public Hearing; Action Items

 a) Avalanche Liquors LLC d/b/a Avalanche Market and Liquor 1705 Airport Rd, Unit 3 Retail Liquor Store

Ms. Kate Weller, owner, was present on behalf of the application. Ms. Weller stated she has lived in Breckenridge for twenty-two years and has a background in the retail and service industries. She mentioned it has been a dream of hers to open a wine shop and plans on taking the sommelier exam next fall. She feels this location, with all the housing on that end of town, would be a great fit for this type of business.

Ms. Gail Marshall, a resident of 1705 Airport Rd, was present and voiced her concern that a liquor license in a mixed-use building does not seem appropriate, and is concerned that this type of business would expose residents to unsavory activities and an increase in crime.

Ms. Power asked Ms. Weller what her anticipated hours of operation would be, and Ms. Weller stated they would probably be 10:00 am - 10:00 pm, perhaps closing earlier when business is slower.

Ms. Girvin asked about parking and the number of units in the building. Ms. Weller stated that each owner gets two parking spaces, but they are not assigned. There are four commercial units on the lower level, and six residential units on the second level. When she gets far enough along to hold tastings, she said she will ask people to park in the free skier parking lots, rather than right outside the building.

Ms. Lovely asked what type of market items she plans to carry. Ms. Weller stated she would eventually like people to be able to pick up basic food items, not a full grocery haul. She would need to have a division of space for the two businesses, so the space and demand will help determine how it unfolds.

Ms. Girvin asked Assistant Chief Gress, who was present on behalf of the Breckenridge Police Department, about crime in that area, and if people purchase alcohol at other liquor stores in town and consume it right outside the business. Assistant Chief stated he does not recall crime in that area being any different than anywhere else in Breckenridge, and that no, people typically purchase alcohol to consume elsewhere, not outside the premises.

The Authority asked Ms. Weller about TIPS training and she stated that she and any employees would be TIPS trained and work with Detective Johnson on ID verification and any other issues that would arise.

Ms. Marshall stated that there are other residents that would have liked to attend to voice their concerns as well but were unable to because of work. Chair Power stated the Authority had received and read four letters of opposition, including one from Ms. Marshall.

The conversation veered back to parking and potential issues that could arise. Ms. Girvin mentioned that parking may prove to be an issue, one that would most likely still exist regardless of what type of business opens in that location, whether it be by employees or customers. Ms. Girvin stated there probably is a need for this type of business in that part of town. It would be nice for Airport Road area residents to not have to come into the core of town for everything.

Ms. Zimmerman stated she used to live in a similar mixed-use building, with a liquor store nearby, and was not aware of any issues created by that type of business.

Mr. Conway stated he thinks this specific location is not the most ideal, in relation to traffic pulling in and out of the parking lot but sees the need in this growing area of town.

Chair Power stated she used to live in this neighborhood and can see the demand for this type of business. She thanked Ms. Marshall for taking the time to attend

the LMLA meeting and mentioned that if approved, the Authority, and neighbors, can always come in to speak, or voice opposition of the license being renewed, should crime go up, or other major issues occur.

Ms. Girvin motioned to approve a new Retail Liquor Store liquor license for Avalanche Market and Liquor. A roll call vote was taken, and the motion passed 5-0.
