I) CALL TO ORDER, ROLL CALL

II) APPROVAL OF MINUTES

A) TOWN COUNCIL MINUTES – October 24, 2023

With no changes or corrections to the meeting minutes of October 24, 2023, Mayor Mamula declared they would stand approved as presented.

III) APPROVAL OF AGENDA

Town Manager Rick Holman stated there were no changes to the agenda. Mayor Mamula declared the agenda approved as presented.

Chris Kulick, Planning Manager, stated this request would extend sections of the development agreement for Breckenridge Grand Vacations. He further stated the proposed motion would extend the provisions of section 2 for 6 months.

Mayor Mamula opened the public hearing. There were no comments and the public hearing was closed.

Council Member Carleton expressed his disappointment that he understood we had asked for \$100,000 in each period, and while he will vote for this, be believes the community is losing that money for childcare.

Council Member Bergeron moved to EXTEND BRECKENRIDGE GRAND VACATIONS VESTED DEVELOPMENT AGREEMENT. Council Member Beckerman seconded the motion.

The motion passed 7-0.

Town Manager Rick Holman stated there was no report. Deputy Town Manager Shannon Haynes stated staff will be testing the Blue River Plaza holiday lights tonight. She also stated Town planners have been speaking to businesses about lighting requirements and staff will be communicating the lighting changes discussed by Council this afternoon. B. BRECKENRIDGE OPEN SPACE ADVISORY COMMITTEE

Council Member Bergeron stated the meeting included updates on Peabody Placer, the Quandary Peak parking program, the proposed rerouting of the perimeter trail, and a packet with trail options presented by a group from Shock Hill that was also forwarded to Council. He further stated BOSAC is divided on the preferred route of that trail and will make a decision this winter.

Scott Reid clarified the Shock Hill maps were handed out at the meeting and staff will create a response in January that will include the maps.

C. BRECKENRIDGE TOURISM OFFICE

Council Member Carleton stated lodging is up 2% in booked room nights for this season, and winter events will take place December 2nd, including the dog parade and the Lighting of Breckenridge and the Santa Race. He also stated the Ullr Parade and Shot ski will be happening, and the Snow Sculpture Championships has 12 teams confirmed. Council Member Carleton stated the resident survey is out in Spanish and English and they are advertising it in the community.

Council Member Owens stated there was a large group of Venezuelans who recently settled in Carbondale and this may happen in other resort communities as well so we should be prepared if it does.

Council Member Carleton stated the neighbor by 114 South Main Street is concerned about the common border to her property with the new building and she would like to see if there is mitigation possible.

Council Member Beckerman stated there is concern in our hockey community about a European hockey incident involving a blade to the neck and they are discussing neck guards and the safety of our athletes, especially children. Council Member Carleton stated the national organization is strongly encouraging neck guards, but they will be difficult to find. He also stated Canada requires neck guards, and hopefully those will be required in the future.

Mayor Mamula thanked Council and staff for a nice going away celebration for himself (term limited), the retiring Town Manager and the other term-limited Council member.
