Garrett asked if any communications in favor of, or in opposition to the application had been received? There were no communications received.

The following is an abbreviated summary of what transpired at the hearing. A verbatim digital recording was made of the entire hearing as required by the Rule 26.12 of the Rules of Procedure of the LLA.

Chair Garrett continued by asking the applicant to present any evidence in support of the application. Luke Salayandia, introduced himself. He stated the family had a restaurant in New Mexico which they sold but is still in operation. They also had a restaurant in Fort Lupton. The building was sold and they had to close. Mr. Blank asked what kind of food would be served? Luke responded they will be serving Northern New Mexican food, the hours of operation will be from 6:00 a.m. – 10:00 p.m. It has not determined, at this time, if the bar would stay open after the kitchen closes. The LLA asked that the employees be TIPS trained and that they work with Sgt. Hughes with the Safe Bar campaign. Mr. Salyandia presented the Authority with the petitions.

Chair Garrett asked if there was anyone present who would like to speak in opposition to the application. There was no one present.

Chair Garrett asked if the Authority had any further questions for the applicant. Chair Garret declared the hearing on the application was considered closed.

Mr. Montepare moved to approve the application of La Montana Linda Mexican Restaurant & Cantina LLC d/b/a La Montana Linda Mexican Restaurant & Cantina for a new Tavern Liquor License for the premises to be located at 110 South Ridge Street, based on the applicant's showing of the reasonable requirements of the neighborhood and the desires of the citizens and subject to the applicant receiving a favorable background investigation. The motion passed with all members in favor of passage.

Ms. Katz moved to amend the day's agenda to include a resolution finding probable cause to believe that Cox Enterprises Inc. c/b/a Cecilia's has violated a law, rule or regulation with respect to the operation of its license premises; setting a hearing with respect thereto; and directing the issuance and service of a notice of hearing and order to show cause as to why the tavern liquor license of such licensee should not be suspended or revoked. Mr. Montepare made the second. All members were in favor of the motion. Discussion continued in reference to scheduling a show cause hearing. It was determined that the LLA will aim for the May 18 meeting at 9:00 a.m. All members were in favor of the motion. For the Authority's next meeting, Mr. Berry will draft a memo in reference to this matter.
