The Joint Upper Blue Master Plan (JUBMP) is a planning document, adopted by the Towns of Breckenridge and Blue River and Summit County, which provides overall guidance on land use decisions and other important growth-related issues in the Upper Blue Basin. The JUBMP sets forth a common shared vision for the future, and informs citizens, landowners, and developers of the desired future for the basin as articulated by the adopting jurisdictions. The proposed update represents the first update to the Plan since its original adoption in 1997.
